


LPG Exports US-Japan v USG-FE Freight

- In September 2024, Japan imported 352,400 tonnes of LPG from the U.S., a 15% decrease compared to August, accounting for 59% of the country's total LPG imports. Over the first three quarters of 2024, U.S. LPG exports to Japan totalled 4.9 million tonnes, marking a 10% decline compared to the same period in 2023. The decline was due to weaker petrochemical demand and Japan's shift to LNG, reducing overall LPG imports.
- Freight rates on the U.S. Gulf to Japan route mirrored the drop in import volumes. Rates started at \$114.0/tonne in early September and decreased to \$87.5/tonne by the end of the month, averaging \$95.3/tonne. The LPG market faced challenges recovering, weighed down by excess tonnage, low product demand, and increased output, resulting in limited optimism among market participants.
